# PRESIDENT'S REPORT 2021 NEW ZEALAND SOCIETY OF NOTARIES INC

#### Membership

At the date of this report the number of members of the NZ Society of Notaries is 191.

#### **Notarial Applications**

The Society is pleased to advise the completion of 4 new notarial faculties so far in 2021 with several more about to undertake tutorials and send their applications to the Master in London.

#### Council

The Council held a full meeting by Zoom after the AGM on 7 September 2020 and it also met face-toface in Christchurch on 22 February 2021. Minutes of both meetings were distributed previously to all members of the Society and are available to view in the *For Notaries* section of the website. Council also holds monthly Zoom meetings to deal with an increasing number of matters, but primarily to discuss the notarial applications and keep those moving along.

Council will be holding a face-to-face meeting in Auckland on Monday 20 September 2021 immediately following the AGM.

#### **Annual Accounts**

The annual accounts cover the period from 1 April 2020 to 31 March 2021. Owen Williams as the Society's honorary auditor has reviewed the accounts of the Society for the year ended 31 March 2021 and we thank him accordingly.

The accounts confirm that the surplus as at 31 March 2021 is \$59,908.26. The increase from the previous year was \$22,995.93 which resulted from an increase of income from subscriptions, an overseas travel refund in relation to C.L.A.N. (formerly WON), and no costs of Stewart Germann as President attending overseas meetings due to COVID-19. The Society is in a healthy financial position.

# **Membership Fees**

Subscriptions to October 2021 are all paid up and subscription invoices for the next year will be issued shortly after the AGM.

# Education

Council is delighted to announce that it recently appointed Jane Montgomery, notary of Christchurch, to conduct tutorials for South Island applicants. Richard Wilson continues to conduct tutorials for North Island candidates and we thank Richard.

Council has published a selection of educational videos now available the website which I recommend you look at.
