The meeting was opened by the President at 1.02pm and quorum of 10 reached.

1 Apologies

The President noted receipt of 34 apologies and advised the list would be appended to the Minutes.

2 Deaths

3 Minutes of 2019 AGM

The minutes of the 2019 AGM were made available for members to review. There being no comments or matters arising from the previous AGM minutes the President moved that the 2019 AGM minutes be accepted.

4 Adoption of President's Report

The President reviewed his annual report to the Society and summarised the main points therein. He noted there were 190 members, 4 new appointments and 12 applications in London waiting on the Master's approval. He noted there had been a backlog in London due to COVID but those awaiting their faculty should receive them in due course. The President advised the rest of his report would be covered further in the meeting.

5 Annual accounts for the period 1 April 2019 to 31 March 2020

The President advised that the annual accounts had been prepared by the Society's auditor Owen Williams and he wished to acknowledge Owen's continued assistance. He noted surplus funds of \$36,000 and a lower deficit of \$8,000 compared with 2019.

The President asked if there were any queries in relation to the accounts. No questions having been raised, the President moved that the financial records for the period 1 April 2019 to 31 March 2020 be approved.

6 **Increase in subscriptions**

As outlined in the previous Council minutes and the President's Report it was considered an increase in the annual subscription was required. It was noted there had been no increase to the subscription for several years. Allen Mazengarb, the Society's Treasurer, advised he recently undertook a simple budget and concluded that the costs to the Society were projected to continue to exceed income and that to have a sufficient buffer, it would be necessary to increase the subscription to \$200 per year. The President asked if there were any queries in relation to the proposed increase in subscription. There being no comment the President moved that the subscription be increased to \$200 per annum.

The offices of President, Vice President, and Treasurer will be subject to election of those roles at the Council meeting to be held after the AGM.

8 **General Business**

The President opened the meeting for any items of general business.

(a) **Donation by Tony Ivanson**

The President opened the general business with a note of thanks to Tony Ivanson who recently advertised his seal stamp for sale and donated the proceeds of that sale to the Society towards the Scholarship.

(b) **Dinner for Bob Eades**

Sadly, due to the COVID-19 restrictions the dinner for Bob Eades' retirement hosted by the ADLS could not take place. It will be rescheduled for some time in 2021. The President noted that Tony Herring and Richard Wilson have agreed to take over from Bob and conduct the tutorials for the notary public applicants and he thanked them for their support..

(c) **Website, Forum, Precedents**

Don Thomas advised that Council is meeting next week with the website designer. He asked that if members have suggestions, please forward any comments. Council would encourage members to use the forum. There have been some precedents uploaded and Council would welcome further examples from notary members.

Mike Scannell advised that he, Julie Hutton and Bruce Stewart had undertaken some training videos for the website and several had been uploaded to the Society's website recently and were undergoing some final adjustments before being made visible to the membership.

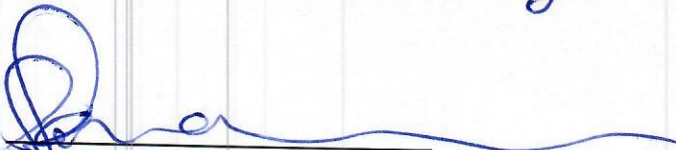
(d) **Thanks to the Secretary**
